6. All equipment and materials must be new. Used or rebuilt equipment or materials are not eligible.
7. All energy efficiency improvement work must be completed during the above-noted effective dates.
8. Equipment and materials must be properly installed. Your Me² Consultant will determine if materials and/or equipment have been properly installed at your post-test.
